- ✓ For many years I requested a bilingual education (Catalan and Spanish) from my children's school.
- ✓ The answer was always NO and so I went to court.
- ✓ In May 2015, the court gives me the reason.
- ✓ On May 11, 2015, The school director asks me in a meeting if I want to continue with the application of the court ruling. My answer is yes
- ✓ On May 12, one day later, my children come home crying, other children accuse them of being the ones asking for more Spanish



May 13, the school appears full of posters against the judicial resolution.

They read "Catalonia is not Spain". The center does NOT remove them



- ✓ That same day in the afternoon a demonstration was called at the door of the school against studying in Spanish in two courses.
- ✓ The call is made by "Som Escola" a platform that are part of the union USTEC or the Bofill Foundation
- ✓ 1000 people attend the demonstration and shout "Independence"

- ✓ Several teachers attend the demonstration, accusing us of having political interests [Félix Galcerán.mp4 - Google Drive](#) and attacking the Catalan language [Carles Mora.mp4 - Google Drive](#)
- ✓ The president of the association of mothers and fathers of the center makes public the course that my children study, which allows to identify them

- ✓ We complain about the situation to the school principal, advises us to take our children to another school
- ✓ The classmates of my children begin to make hurtful comments " let me pass or I have to tell you in Spanish"
- ✓ The school informs us that the next course will give mathematics in Spanish but in the list of books, the math book is in Catalan
- ✓ We complain and the school tells us that there are no suitable books in Spanish
- ✓ The harassment of my children, the contrary position of the teachers, the refusal of the center to properly fulfill the sentence and political pressure forces us to make the decision to change center

- ✓ I switched my children to a school at a cost of €10,000/year for each child
- ✓ I pay my taxes for a school that does not respect my children's rights or protect them from harassment
- ✓ My family was not defended by the Generalitat, the Spanish Ombudsman or the Catalan Ombudsman. Only civic associations and anonymous citizens
- ✓ Fighting so that our children can also study in Spanish in Catalonia has a **high cost**
